

## **Gist of the measures taken by Sri Devaraj Urs University to make the campus ragging free**

As per the guidelines/regulations of the Medical Council of India and the University Grants Commission respectively, the University has instructed Sri Devaraj Urs Medical College the constituent unit of the University who has implemented the following measures to curb ragging in the campus.

1. All students getting admitted are to furnish a character certificate and any negative entries will be monitored intensely.
2. An Annual undertaking signed by the students as well as the parents of both freshers and senior students stating that they have fully understood the laws prohibiting ragging, the consequences of indulging in ragging and punishment for the same (Format enclosed).
3. An Anti Ragging Committee is to be constituted and is functional round the clock.
4. A mentoring cell has been constituted to select senior students as mentors for freshers.
5. Professional counselors are available to counsel freshers.
6. Posters have been put up all over the campus defining what is ragging and the consequences of ragging.
7. A sensitization programme will be held in the 1<sup>st</sup> week of July 2009 and counseling of both freshers and seniors will be done.
8. Any complaints about ragging even if received from a third party will be treated with confidentiality.
9. In case any episode of ragging does take place, remedial action will be initiated and completed within a week of the incident. In case, the victim of ragging, his / her parent guardian is not satisfied with the action taken by the Head of the Institution, the institution will have to file a First Information Report (F.I.R) with the local police authorities.

All students who have already taken admission in the college as well as those seeking admission to the college must strictly adhere to the above regulations to make the campus ragging free.

Lapses in this regard will be viewed seriously.

**SECTION 116: PENALTY FOR RAGGING:**

1. No person who is a student in an educational institution including in institution under the direct management of the University or of the central Government shall commit ragging.
2. Any person who contravenes sub-section 1. shall, on conviction, be punished imprisonment for a term which may extend to one year or with fine which may extend to two thousand rupees or with both.

**SECTION 2(29):**

“ Ragging means causing, inducing, compelling or forcing a student, whether by way of practical joke or otherwise, to do any act which detracts from human dignity or violates his person or expose him to ridicule or to forbear from doing any lawful act, by intimidating wrongfully confining or injuring him or by using criminal force to him or by holding out to him any threat of such intimation, wrongful restraint, wrongful confinement, injury or the use of criminal force;
